File for a primary residence exemption with the county assessor to potentially qualify for property tax savings.
Sign up for "Property Watch" from your county recorder (if available)
Arrange for payment of HOA/Association dues and ensure that you are aware of the payment schedule and any specific requirements.
Coordinate with the seller to transfer the utilities into your name and set up any desired automatic payments or billing preferences.
Arrange for the changing of locks either through a locksmith or your home warranty company.
Identify the garbage and recycling pick-up days in your new neighborhood to properly dispose of waste and recycling materials.
Set up or transfer TV/internet services and gym memberships according to your preferences and needs.
Familiarize yourself with the location of shut-off valves for water and gas in case of emergency situations.
Forward your mail using the United States Postal Service (USPS) online forwarding service.
Take pictures of receipts for any deductible expenses related to the purchase of the property or potential reimbursements.
Prepare for moving day by fully charging your cell phones, having essentials like paper towels, bathroom tissue, and plastic cups/utensils readily available. Also, keep some cash on hand for unexpected expenses.
Inform your insurance agent about your new home and ensure that your homeowner's insurance policy is active and covers the correct property.
Consider creating a home maintenance checklist to keep track of regular tasks such as changing air filters, servicing HVAC systems, or scheduling lawn care.
Research local service providers, such as plumbers, electricians, and landscapers, and keep their contact information handy for any future needs or emergencies.
Familiarize yourself with any homeowner association (HOA) rules, regulations, and restrictions, and ensure compliance with their guidelines.
Take the time to explore your new neighborhood and introduce yourself to neighbors, making connections and getting to know the community.
Several companies & service providers may require notice of your new address.
Auto, life, & health insurance companies. (Ensure your policies reflect the correct information and coverage).

Benefits of Title Insurance – Built in coverage for marketable title, fraud & forgery

While the news coverage shed light on this issue, it's worth noting that numerous homeowners are already safeguarded by their title insurance policies, often acquired at the time of property purchase. An Owner's policy encompasses protection against unmarketable titles, and many policies obtained since 2008 have extended coverage that includes safeguarding against post-policy forgery, fraud, and title-related complications. The specifics of coverage can vary, and deductibles might apply depending on the policy type. Remarkably, many policyholders could potentially have coverage that reaches up to 150% of their property's original purchase price.

Existing title insurance policies offer significant protection for homeowners, and the Property Watch service provides a valuable tool for staying informed about changes to your property.

Corporate Fraud Watch

The Utah Division of Corporations and Commercial Code provides a service to assist businesses in monitoring and receiving notifications regarding changes to their corporate information. These changes may be indicative of identity theft or fraudulent activities. The State promptly sends an email within 24 hours of any modification to a Business Address, Registered Agent, or Registered Principal. DEATH, TRAUMA, AND CRIME SCENE CLEAN-UP

If you have a death or trauma scene that needs to

be cleaned up:

- Wait for the police to clear the scene.
- Do not clean it up yourself, have a professional do it safely and correctly.
- This can be difficult to see and deal with; have a support person close the door or put a sheet up until the professional cleaners arrive.
- Find another place to stay for the night or until the cleaning has been completed.

DEATH OF A LOVED ONE

If you find your loved one deceased, you should obtain a legal pronouncement of death.

If no physician is present, you'll need to contact someone to do this:

- If the person dies at home under hospice care, call the hospice nurse who can declare the death and help facilitate the transport of the body.
- If the person dies at home without hospice care, call 911, and have in hand a do-not-resuscitate document if it exists. Without one, paramedics will generally start emergency procedures and, except where permitted to pronounce death, take the person to an emergency room for a doctor to make the declaration.
- If the paremedics determine an emergency room is not necessary police will work with the medical examiners office to determine need for an autopsy.
- If your loved one has to go with the medical examiner's office, you
 will work with them directly until your loved one can be released.

Arrange for transportation of the body.

If no autopsy is needed, the body can be picked up by a mortuary or crematorium of your choice. If the body needs to be autopsied, the hospital or doctor will notify you. You will work with the medicalexaminer's office until your loved one can be released.

What to do if you or someone you know is suicidal:

- 1. Find out if the person is in danger of harming themselves or acting on suicidal feelings.
- 2. Look for warning signs (statements about suicide, buying weapons/stocking up on pills, withdrawing socially, extreme mood swings, increasing use of substances, risky or self-destructive behaviors, giving away belongings, saying goodbye to people, change of normal routines)
- 3. Encourage the person to reach out to a suicide hotline/web-site/texting service.
- 4. If you are concerned about them or their safety, call 911, or go to the emergency room and get professional help.
- 5. If someone has attempted suicide: Call 911 immediately.

WHAT DO I DO IF MY CHILD OR **TEENAGER IS IN CRISIS?**

- 1. Preventative safety measures include: locking up guns, knives, and other sharp objects; using child safety locks on car doors; removing furniture and heavy objects from the child's room; and locking up all medications and other substances.
- 2. De-escalate the crisis by keeping your voice calm, listening to your child, moving slowly, and giving them space. Do not leave them alone if they are at immediate risk.
- 3. Remember safety first! When your own safety is in question, back up or get out!
- 4. If your child is not in immediate danger, you could call a psychiatrist, nurse, case manager, or therapist that knows your child well.
- 5. If your child poses an immediate risk of danger to themselves or others, call emergency crisis services through Wasatch Behavioral Health at 801-373-7393 or call 911 for law enforcement support.
- 6. If the situation cannot be resolved, or it is recommended by the crisis team or law enforcement officer, taking your child to the emergency department (ED) may be the best option. Keep in mind, that this does not guarantee admission.

If there is not a drop-off location near you:

- Mix medications with wet dirt, cat lifter, or used coffee grounds.
 • Place the mixture in a sealed container or plastic bag.
- Throw the container in your household trash.
- Scratch out all personal information on the prescription label of the empty pill bottles or packaging and dispose of the container.

VICTIMS RIGHTS

- To be informed of the available level of protection from intimidation and harm
- 2. To receive a written notice of shelters, services and resources available in your community
- 3. To receive restitution or reparations, including medical costs and other losses resulting from crime
- 4. To receive reasonable employer intercession services to minimize loss of pay and benefits.
- 5. To receive notice when a person is released following arrest for a domestic violence against you.
- To receive clerical assistance as to your role in the criminal justice process and to be treated with fairness, respect, and dignity.
- 7. To have a timely notice of judicial proceedings you are to attend and timely notice of cancellation of any proceedings.
- 8. To have a sentencing judge who receives and considers reliable information concerning the background, character and conduct of thos convicted for the purpose of imposing an appropriate sentence.
- 9. To have a speedy trial and disposition of charge.
- 10. To wait in a secure area that does not require you to be in close proximity to defendants or family and friends of the defendants.
- 11. To have any personal property returned from criminal justice agencies when it is no longer needed for court, law enforcement or prosecution purposes.

RIGHTS OF CHILDREN

- 1. To have interviews related to criminal prosecution kept to a minimum.
- 2. To be questioned in an appropriate manner their age and understanding.
- 3. To receive protection from physical and/or emotional abuse during their involvement with the criminal justice process.
- 4. To be informed of available community resources and how to gain access to those resources.

DOMESTIC VIOLENCE

If you are currently experiencing domestic violence:

- 1. Plan how you could get out of the house quickly if your partner becomes violent.
- Put together a suitcase and leave it at a friend's house. Include medications, clothing, important papers, car keys, money, and emergency phone numbers.
- 3. Tell your neighbors and have them call the police if they hear anything.
- 4. Teach your children about how to stay safe.

If you are thinking about leaving an abusive partner:

- 1. Identify what you will do if the violence starts again.
- 2. Call the police or work out a signal with the children or neighbors to call for help.
- 3. Find ways to have dangerous weapons removed from the house.
- Plan and practice an escape route. Know where you can go and who you can call for help. Keep a list of addresses and phone numbers.

PROTECTIVE ORDERS

A court can issue a protective order to order another person to:

- 1. Not physically hurt or threaten you, your children or anyone else who lives with you
- 2. Move out of your home
- 3. Give you temporary custody of the children
- 4. Stay away from you, your home, your workplace
- 5. Not contact you in person, by phone, mail, email, etc.

You can get a protective order if:

- Someone has physically hurt you, or threatened to hurt you
- 2. You have a close relationship with that person (for example, you are married, you were married, you are living together, you have a child together, you are expecting a child together or you are close relatives.)
- 3. You are afraid that person may hurt you again

OBTAINING A PROTECTIVE ORDER

To get a protective order is free. You will need to:

- Fill out the needed forms available at any courthouse or online at utcourts.gov/resources/forms/protectorder/
- Turn in the completed forms to the courthouse. Within 24-48 hrs a Judge will sign a temporary order. (called an Ex Parte Protective Order)
- 3. The Ex Parte Protective Order will be effective after a Sheriff gives a copy to the person the order is against
- 4. The temporary order lasts for 20 days or until your court hearing
- 5. The time/date of the court hearing will be written on the Ex-Parte Protective Order. You will need to attend this hearing for the order to extend past 20 days
